1. The above candidates will be eligible to appear for the interview only on production of the requisite documents and fulfilment of the eligibility conditions.
2. After verification of original documents, if it is found that the candidate is not falling in the cut off, as applicable, then the candidate will not be permitted to appear in the interview.
3. The Interview will be conducted in offline mode.
