### FOR THE DEVELOPMENT OF ACADEMIC COOPERATION IN EDUCATION

The general objective of this Memorandum of Understanding (MoU) is to establish a mutually beneficial relationship built on academic, scientific and cultural cooperation. Areas of cooperation between the **Department of Psychology, Central University of Haryana** and the **Department of Psychology, TM Bhagalpur University** include the exchange of faculty professors, researchers, students, publications, academic programs and research projects for the development of collaborative and mutually beneficial programs which will serve to enhance the intellectual life and cultural development of both campuses to contribute to increase educational cooperation.

Thus, Department of Psychology, Central University of Haryana and Department of Psychology, TM Bhagalpur University have agreed in support of their mutual interests in the field of education and research.

The signing institutions agree to provide opportunity, as appropriate, for the following activities towards the completion of the objective of this MOU.

1. Exchange of faculty members and/or researchers with the objective of offering courses and realizing research projects in areas mutually agreed upon by both universities through prior invitation and in accordance with the procedures and expectations established by each university and specific department.
2. Exchange of Post-Graduate students with the objective of enrolling students in courses appropriate to their year and area of study.
3. Support reciprocity in university extension activities of common interest.
4. Exchange of books, scientific publications, study programs, academic projects, course information, seminars, conferences and any other data and information of common interest.
5. Develop joint research projects and joint publications and engagement of students to complete their dissertations, research projects and research thesis under the supervisions of professors in their psychological laboratories.
6. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate university entity.

7. conduct short-term courses, as mutually agreed in writing between the parties prior to commencement of this activity:
8. Conduct study tours mutually agreed in writing between the parties prior to commencement of this activity.
9. The host institution will assist the student with securing housing and offer personal and academic support prior to and during the semester(s) of exchange.
10. The professors and researchers will maintain their status as faculty members at their home institution for the duration of the exchange.
11. The appropriate academic departments and administrative offices will assist in securing housing and other necessary arrangements for living in the host institution's campus.

This agreement will take effect from the date of its signing and shall be valid for an unlimited period from that date unless sooner terminated, revoked OR modified by mutual written agreement between tile Parties, and may be extended by mutual written agreement.

Either party may terminate the agreement at any time during tile term by the provision of three months written notice to the other party.
