FOR THE DEVELOPMENT OF ACADEMY-INDUSTRY-RELATIONS

The general objective of this Memorandum of Understanding (MoU) is to establish a mutually beneficial relationship built on academic and scientific cooperation with the ultimate objective of knowledge sharing. Areas of cooperation between Central University of Haryana and CUTS Institute for Regulation & Competition, include ratification and feedback on course syllabi, research collaborations, study tours, student internship and faculty exchange programmes, joint publications, collaboration pertaining to dissemination of knowledge through on-line courses, presentations, seminars, workshops and conferences, for the development of collaborative and mutually beneficial programs and/or any other area of common interest and benefit.

Thus, Central University of Haryana and CUTS Institute for Regulation & Competition have agreed in support of their mutual interests in the field of education and research.

The signatory institutions agree to provide opportunity, as appropriate, for the following activities towards the completion of the objective of this MoU.

- 1. Ratification and feedback on course syllabi.
- 2. Exchange of faculty members and/or researchers with the objective of offering courses and realizing research projects in areas mutually agreed upon by both institutions through prior invitation and in

accordance with the procedures and expectations established by each institution.

3. Facilitation of internship programmes.

4. Support reciprocity in extension activities of common interest.

5. Exchange of books, publications, study programs, course information, and any other data and information of common interest.

6. Development of joint research projects and joint publications.

- 7. Development and conduct of short-term/on-line courses, as mutually agreed in writing between the parties prior to commencement of this activity.
- 8. Conduct study tours mutually agreed in writing between the parties prior to commencement of this activity.
- 9. The host institution will assist the student/researcher with securing travel assistance, accommodation, fooding and offer personal and academic support prior to and during the tenure of exchange.
- 10. The professors and researchers will maintain their status as faculty members at their home institution for the duration of the exchange.

This agreement will take effect from the date of its signing and shall be valid for an unlimited period from that date unless sooner terminated, revoked OR modified by mutual written agreement between the signatory parties, and may be extended by mutual written agreement.

Either party may terminate the agreement at any time during the term by the provision of three months written notice to the other party.
