

MEMORANDUM OF UNDERSTANDING (MOU)

**BETWEEN THE CENTRAL UNIVERSITY OF HARYANA, (MAHENDERGARH)
AND
EDUCATION WING, RAJYOGA EDUCATION AND RESEARCH FOUNDATION
MOUNT ABU, RAJASTHAN**

This MoU is made on Fifteenth day of April, 2023 between the Vice-Chancellor of the Central University of Haryana (hereinafter called Central University (Party A) and the Chairman, Education Wing, Rajyoga Education and Research Foundation (hereinafter RERF) having its administrative Head Office at Mount Abu, Rajasthan. (Party B)

1. Purpose: The purpose of this MoU is to establish the terms and conditions for setting up, operating and maintaining a Thought Laboratory at central University of Haryana by Regional Coordinator of Thought Laboratory, Delhi Zone under the umbrella of Education Wing, RERF.

2. Scope: Whereas Party A and Party B, have made a MoU for -

- a) The RERF offers a course on “**Innovative Thinking and Positivity**” to students of Central University of Haryana. This course shall be offered as Open Elective Course of 60 hours duration (during one semester) to enable students to get 4 Credit Points. The course content will include 30 Theory Lectures and 30 Tutorial of one hour each (50 Min +10 Min Break) subject to approval by Academic Council or relevant authority of Central University of Haryana.
- b) The theoretical /Lecture sessions will be conducted online and Practical classes in University of campus in the designated accommodation provided for the Thought Laboratory.
- c) Establishing and maintaining a “**Thought Laboratory**” at the premises of the University.
- d) Variety of Joint Educational activities such as Meditation, Creative Activities, Workshop related to Innovative Thinking and Positivity.
- e) Any other such program under the purview of the scope of this MoU as agreed by both parties.

3. Responsibilities:

The Central University of Haryana places significant emphasis on academic and professional quality assurance and recognizes this as a major responsibility. In this MoU, both parties agree to cooperate in the following manner :-

3.1 Regarding Establishment, Maintenance and Functioning of “Thought Laboratory”:

3.1.1 It is the sole responsibility of the Central University of Haryana to provide required space for establishing the “Thought Laboratory” at the premises of the university.

3.1.2 It is the responsibility of the Central University of Haryana to provide and maintain requisite electrical, electronic, mechanical equipment and devices as well as general purpose stores required for the smooth and optimum functioning of the “Thought Laboratory”. Central University of Haryana to provide staff for day to day maintenance and upkeep of the Thought Laboratory, as necessary.

3.1.3 It is the responsibility of RERF to provide technical support in the form of Faculty, Literature to include reference material and any other special equipment and advice to Central University of Haryana for both establishing and maintaining the "Thought Laboratory".

3.1.4 Central University of Haryana to provide still and Video coverage of the important events in the Thought Laboratory.

3.1.5 RERF will take care of only the technical support and resources/advice for the successful implementation of the "Thought Laboratory" including counselling assistance to the students as well as those members of teaching faculty and non-teaching staff who are connected with operations and maintenance of the Thought Laboratory.

3.1.6 RERF will not incur any financial expenditure either in establishing or maintaining the laboratory. Incidental expenses from time to time to be borne by Central University of Haryana through the process of mutual consent.

3.2 Regarding Courseware

3.2.1 The content (syllabus), course delivery method (pedagogy), guidance to students for projects of the course '**Innovative Thinking and Positivity**' to be designed by the **Regional Coordinator of Thought Laboratory Delhi Zone, Education Wing, RERF**. The Course content shall be approved by Central University of Haryana

3.2.2 It is the responsibility of Central University of Haryana and Regional Coordinator of Thought Laboratory to conduct examination and setup evaluation pattern / assessments.

3.2.3 Central University of Haryana to consider to provide remunerations and conveyance allowance to the visiting faculty conducting the approved courses as per existing Central University of Haryana norms.

4. Coordination & Communication:

4.1 For smooth functioning of all activities jointly, each party shall designate a competent coordinator to develop and coordinate the activities as agreed upon herein this MoU and later in the program specific schedule.

4.2 BK Sudesh, Palam Vihar, Regional Coordinator of Thought Laboratory, is designated as the Co-ordinator for all such programmes in Central University of Haryana.

5. Review and Evaluation of Outcomes:

Both parties will review and evaluate outcomes of joint activities at the end of each academic year and shall make recommendations for the further development.

6. Modification of Agreement:

Revisions or modifications may be proposed at any time, which will be effective only after the date of written /MoU or agreement signed by both parties.

7. Resolution of Disputes:

In the event of any dispute or grievance, a joint committee will review the issue and reach an amicable solution. If the committee cannot resolve the issue, then, it will be referred to the higher level authorities

of both the parties in progression. If the understanding or agreement is still not reached then the terms of the MoU may be reviewed to determine the next course of action including the termination of the MoU. In the event of the termination of the MoU, all the parties to work together in the best interests of the students enrolled into the joint programs.

8. Termination Clause:

Any party may terminate the MoU with three (3) months of advance notice in writing, unless an earlier termination is mutually agreed upon.


9. Duration of MoU:

This MoU is valid for five (5) years from the effective date.

10. Effective Date:

This MoU becomes effective from the date of signing of this MoU.
