Mahendragarh, Haryana, India (hereinafter referred to as "CUH" represented by Its Registrar the context so admits includes its successors and assignees) as SECOND PARTY agree to enter into a Memorandum of Understanding to facilitate collaborative research and promotion of Millets

Now it is hereby agreed as follows:



Article 1. Scope of cooperation

The scope of this MoU covers :

1. Student exchange programme: RJC will accept students from the SECOND party on set principles upon available vacancies for work in Physics or other value added research in Nuclear Physics or any other disciplines related to Physics.
2. Organizing joint conferences / seminars / workshops / STCs: Both the organizations accept to jointly organize seminars/ symposiums/ training programs in the purview of Physics research and development and also for Physics promotion.
3. Sharing of research and infrastructural facilities: To share their respective important research and development (R&D) facilities in order to promote research interactions in the areas of cooperation on basis as levied by the respective institutes. To share laboratory, library and other supporting facilities to the personnel concerned in the areas of cooperation on the basis as levied by the respective institutes.
4. Collaborative research: The concerned scientists of both the organizations will formulate research projects with due approval of both the institutes for funding extramural grants to agencies especially in the area of Physics and value addition. Both the organizations may impart training to staff, students and technical personnel within the areas of cooperation. Both organizations may jointly publish and present the joint research works in different Scientific Forums.

Article 2. Mechanism for implementation

For the purpose of implementation of this MoU Ramjas College, University of Delhi, Delhi represented by Prof. Manoj Kumar Khanna, Principal and Central University of Haryana represented by Registrar, CUH.

Contact person of the MoU from RJC side (member) Dr. Amanjeet, Assistant Professor, Department of Physics, Rmjas College, University of Delhi, Delhi

Contact person of the MoU from CUH side (member) Dr. Suneel Kumar, Professor Department of Physics and Astrophysics, Central University of Mahendergargh, Haryana

These representatives may meet as and when necessary to draw plans of action and to review the progress in the implementation of the agreed arrangements as outlined in Article 1.

If necessary, separate subsidiary agreements may be signed for one or more of the activities mentioned in Article 1 for specific details and terms and conditions. All activities under this MoU shall be subject to availability of resources and approval by the competent authorities of the respective organizations.

Article 3. Financial obligations

For each activity outlined in Article 1 the extent of financial commitment by the two organizations will be separately negotiated and agreed upon subject to financial approval from their respective BOG/ Governing bodies. Prior to final agreement and the carrying out of any activity arising from this MOU both Ramjas College, University of Delhi, Delhi and Central University of Haryana must obtain the concurrence in writing of their respective finance / Accounts and Audit Sections.

Article 4. Duration of MoU



This MoU will come into force on the date of its execution by the authorized signatories of Ramjas College, University of Delhi, Delhi and CUH and shall remain in force for a period of 2 years and may be renewed upon its expiry with the agreement of both parties.

Either RJC or CUH may terminate the MoU by giving 2 months' notice in writing to the other party. The termination of this MoU shall not affect the implementation of the activities already established under it prior to such termination.

Article 5. Amendments

This MOU may only be amended by mutual agreement evidenced in writing by a duly authorized representative from both the organizations.

Article 6. Intellectual Property



Any intellectual property arising out of the implementation of this MoU shall be secured and maintained by mutual consent according to the provisions of of RJC Rules and regulations and those of CUH rules updated time to time.

Article 7. Settlement of Disputes

Any dispute, conflict of interest or problems arising from the application or interpretation of this MoU shall be resolved by mutual discussion and in good faith by the designated representatives of both the organizations as mentioned in Article 2.

Article 8. Legal status

Nothing in this MoU shall be construed as creating any legal relationship between the parties. This MoU is a statement of intent to foster genuine and mutually beneficial cooperation.
